EAST BATON ROUGE PARISH VIOLENCE REDUCTION COLLABORATIVE

Mayor-President Sharon Weston Broome brought together Local, State, and Federal Law Enforcement, other Municipal and Parish Agencies, and business and community partners to form the East Baton Rouge Gun Violence Collaborative.

After a 3-day strategic planning session, led by Dept. of Justice Public Safety Partnership facilitators, these agencies develop a joint strategic plan that will reduce gun violence over the next 3 years using strategic collaborations and resource sharing focusing on community-based approaches, individuals and groups engaged in violence, and locations where violence is occurring.

- Increasing investments in community outreach, community engagement, and partnerships focusing on reducing gun violence;**
- Coordinating and enhancing law enforcement strategies and partnerships to investigate, prosecute, and reduce gun violence;**
- Leverage municipal services to address the conditions that contribute to gun violence;**
- Employ sound means and methods to identify and concentrate efforts on violent persons, groups, and places to reduce gun violence.**

These specific focus areas, goals, strategies will lead the fiscal planning for use of ARP dollars, grant procurement, general fund budgets, and public-private partnerships to advance successful outcomes.
