Fireside Chat with Kelly Lytle Hernandez - Bria Gillum Moderator

Kelly Lytle Hernandez is a historian, 2019 MacArthur Fellow who is challenging long-held beliefs about the origins, ideology, and evolution of incarceration and immigrant detention practices in the United States. She currently leads the Million Dollar Hoods research project, which maps the fiscal and human costs of incarceration in Los Angeles County. Lytle Hernández's investigation of the intersecting histories of race, mass incarceration, immigration, and cross-border politics is deepening our understanding of how imprisonment has been used as a mechanism for social control in the United States.
